THE DEPARTMENT OF CLIENT SERVICES PROVIDES SERVICES PRIMARILY TO PEOPLE LIVING WITH HIV/AIDS. SERVICES INCLUDE CASE MANAGEMENT, HOUSING ASSISTANCE AND SUPPORT, SELF MANAGEMENT, MENTAL HEALTH, INSURANCE/MEDICATION ACCESS, AND COMPREHENSIVE SUPPORT SERVICES FOR ALMOST 2000 PATIENTS TO ENSURE THAT THEY CAN ACHIEVE MAXIMUM CLINICAL OUTCOMES AS WELL AS IMPROVE THE QUALITY OF THEIR LIVES.
